

**RESOLUTIONS TAKEN AT THE 39<sup>th</sup> BT/TCMG MEETING  
BRUSSELS, 2009-05-28**

**RESOLUTION BT 16/2009**

**(39<sup>th</sup> BT/TCMG item: 2.1)**

Subject: Construction Sector – Use of electronic means for supplying accompanying data with CE marking

BT/TCMG, on behalf of BT,

- considering
  - the request from the European Commission not to have clauses in standards to be harmonized under the Construction Products Directive (CPD) that allow for the use of manufacturers' web sites to provide information required with the CE marking;
  - that a number of candidate harmonized product standards containing such clauses have progressed to finalization;
- recommends Technical Committees, having drafted candidate harmonized product standards allowing for the use of manufacturers' web sites to provide information required with the CE marking, to remove all relevant clauses in order to allow the citation of these standards in the OJEU under the CPD and allows them to carry out this removal through corrigenda;
- recommends Technical Committees involved in the drafting of candidate harmonized product standards to avoid any clauses that allow for the use of electronic means for supplying accompanying data with CE marking in order to allow the citation of these standards in the OJEU under the CPD;
- invites BT/WG 102 to continue discussion with EC in order to search ways to use electronic means for supplying accompanying data with CE marking.
