The rapporteur proposed the following technical amendments following the agreement on adjustment of the financial perspective for enlargement (Böge/Colom i Naval report). The President noted that they would be taken into account:

Recital D was amended as follows: "whereas the ceiling in heading 5 ("Administrative expenditure") of the financial perspective was fixed at EUR 5 983 million¹ at 2004 prices; whereas

the margin under the financial perspective will remain under pressure due, among other things, to enlargement-related expenditure in the European institutions."

¹ Excluding EUR 174 million in staff contributions to the pension scheme

Paragraph 42 was amended as follows: "Agrees to a total amount of EUR 1 231 million for the estimates under the 2004 Budget and as specified in the Annex, which corresponds to 20% of heading 5 ("Administrative expenditure"); reserves its position until Parliament's first reading in autumn, pending further developments, on the total amount for Section I;"
